Supplementary Childcare Service (SEB) and Supervised Lunch for Kindergarten and Primary School Children



Lunch, afternoon and after-school childcare

The supplementary childcare services for school children, SEB, are aimed at children of kindergarten an primary school age and are organized in three modules per day, from Monday to Friday, during term-time. The registered children are professionally cared for under pedagogically trained supervision in specially equipped rooms. Lunch in module 1 is delivered to all the locations. Homework supervision is included in modules 2 and 3. An all-day camp is available for a maximum of 11 weeks of the school vacations (see separate flyer).

Registration and organization

Attendance at a SEB is only possible with a binding registration for an entire school term. Each of the modules can be attended individually and for between one and five days a week. The registration of least five children per location and module (or per day of vacation camp) is required for these childcare services to be provided.

In the case of the vacation camps, a child has to be registered for the entire day. The children have to be able to make their own way to the SEB. Any transport costs are to be covered by the parents/legal guardians.





Costs

This range of childcare services is subsidized by the municipality of Reinach for children who are resident in Reinach. The contribution of the parents/ legal guardians to the costs of the childcare is determined on the basis of their income level. The relevant income is determined on the basis of the data submitted to our fiscal administration. Calculations are made according to the Regulations Governing Supplementary Childcare. The full costs are charged for children who are not resident in Reinach. More detailed information is available at www.reinach-bl.ch.
